TERRACOTTA IMPREGNATOR

Deep-penetrating, invisible, water-repellent, treatment for the protection against water and rising humidity of cotto and terracotta.

TERRACOTTA IMPREGNATOR is a water-based, water-repellent-impregnating treatment that provides deep-penetrating, effective, and completely invisible protection to cotto and terracotta against water absorption and rising humidity.

TERRACOTTA IMPREGNATOR can also be used as a grout release treatment: if applied to cotto or terracotta before proceeding with washing and grouting operations, the product will effectively protect the material against grout stains and water absorption, making it possible to intervene with successive treatments and delivery of the finished work very quickly. It can also be used as a water-repellent primer before applying a stain-proofing product.

USES

Suitable for indoor and outdoor applications.
Suitable for Cotto, Terracotta, Cement-marble agglomerate, Concrete, Concrete tiles, Tuff, Porous stones.

COVERAGE

10/15 m²/l according to the absorption level of the surface being treated

APPLICATION EQUIPMENT

Brush, roller, lambswool applicator, airless spray, cloth

APPLICATION STEPS

Before applying the product it is necessary taking a preliminary test to evaluate the suitability of the product on an unexposed area or unused piece of material

Surface Preparation

- Carefully clean the surface, making sure to remove any dust or dirt present.
- Wait for the surface to be treated to be completely dry.
- All surfaces close by not being treated must be protected
- Apply the product on surfaces with a temperature between +5 e +40°C

Application

- The product must be diluted before the application. Dilute 1 part of product into 2-3 parts of water.
- Apply an even layer of product to cover the whole surface being treated, using the preferred tool. Make sure to create a layer that is as seamless and even as possible.
- The product will be visibly dry after a few minutes from its application. Before applying any other treatment it is necessary to wait for the surface to be completely dry. We recommend waiting at least 24 hours.

Resume surface use

Wait at least 6 hours from the application before resuming the use of the surface.

COMPLEMENTARY MAINTENANCE PRODUCTS MANUTENZIONE

After the treatment with **TERRACOTTA IMPREGNATOR** we recommend using the most suitable Faber cleaner, such as **NEUTRAL CLEANER** or **FLOOR CLEANER**, depending on the nature of the surface.

INSTRUCTIONS AND GUIDELINES

- Do not apply the product on wet or heated surfaces
- When applying to recently laid or grouted surfaces, wait for the adhesive or grout to cure completely.
- When used as a pre-treatment before grouting wait at least one full day before proceeding with the grouting operations.
- Before applying the product it is necessary to take a preliminary test to evaluate its suitability

EQUIPMENT CLEANING

The equipment used can be cleaned with white spirit

STORAGE

Keep the container tightly closed and store in a cool, dry place.

PACKAGING

1 l bottles - 12 bottles per box
5 l bottles - 4 bottles per box

ACCIDENTAL SPILLS

Soak up the product with an absorbent material (paper towels, sawdust, vermiculite, etc.) and dispose of it in the most suitable waste container.

When applying the product, always use suitable personal protective equipment and follow the instructions on the product safety data sheet with care.
