**AQUA TREATMENT** is completely free from volatile organic compounds (VOC Free). It is also eco-compatible and certified safe to be used with surfaces in contact with foods. This is why it is the ideal stain-proofing treatment for kitchen tops made of stone or agglomerates.

### COVERAGE

10/15 m<sup>2</sup>/l according to the absorption level of the surface being treated

### APPLICATION EQUIPMENT

Brush, roller, lambswool applicator, airless spray, cloth

### APPLICATION STEPS

*Before applying the product it is necessary taking a preliminary test to evaluate the suitability of the product on an unexposed area or unused piece of material*

#### *Surface Preparation*

- Carefully clean the surface, making sure to remove any dust or dirt present.
- Wait for the surface to be treated to be completely dry.
- All surfaces close by not being treated must be protected

#### *Application*

- Apply an even layer of product to cover the whole surface being treated, using the preferred tool. Make sure to create a layer that is as seamless and even as possible.
- After about 10 minutes from the application, make sure that there are no residues or excess product on the surface, and redistribute them if necessary, until they are completely absorbed.
- When applying the product to more absorbing surfaces, apply a second coat about 1 hour after the first one, following the same procedure described above.

**APPLICATION STEPS***Resume surface use*

Surfaces will be dry about 1 hour from product application. When used on floor surfaces, wait at least 4-6 hours before opening the floor to foot traffic.

**COMPLEMENTARY MAINTENANCE PRODUCTS MANUTENZIONE**

After the treatment with **AQUA TREATMENT** we recommend using the most suitable Faber cleaner, such as **NEUTRAL CLEANER** or **FLOOR CLEANER**, depending on the nature of the surface.

**INSTRUCTIONS AND GUIDELINES**

- Do not apply the product on wet or heated surfaces
- When applying to recently laid or grouted surfaces, wait for the adhesive or grout to cure completely.
- When used on terrecotta and high-absorbing materials **AQUA TREATMENT** can be applied after a water-repellent sealer. If that is the case it is necessary to wait for the water-repellent sealer to dry completely.
- Before applying the product it is necessary to take a preliminary test to evaluate its suitability

**EQUIPMENT CLEANING**

The equipment used can be cleaned with water

**STORAGE**

Keep the container tightly closed and store in a cool, dry place.

**PACKAGING**

1 l bottles - 12 bottles per box  
5 l bottles - 4 bottles per box

**ACCIDENTAL SPILLS**

Soak up the product with an absorbent material (paper towels, sawdust, vermiculite, etc.) and dispose of it in the most suitable waste container.

**SAFETY**

When applying the product, always use suitable personal protective equipment and follow the instructions on the product safety data sheet with care.
